<p>School Trips Parental Permission for Students to Leave Oakwood School for trips and visits within a 20 mile radius. In an effort to reduce form filling requirements, Oakwood School has decided to request a 'Parental Permission Slip' from Parents/Carers. This will give permission for students to be taken out of school to attend trips, visits and other activities within a 20 mile radius of Oakwood School with the teacher in charge of each trip acting in loco parentis. This will greatly reduce the responsibility on parents to complete a form prior to each individual trip from school. I understand details of the trip/visit will have been previously supplied. I acknowledge the need for obedience and responsible behaviour on his/her part. I understand that the teacher in charge of each trip will be acting in loco parentis and in the event of an accident, I agree to my son/daughter receiving emergency medical treatment which might include the use of anaesthetic and blood transfusions as considered necessary by the medical authorities present. I agree to my son/daughter being taken out of school to attend trips and visits within a 20 mile radius of Oakwood School throughout the academic year and to his/her participation in all activities included in the trip/visit.</p>
